Procurement of Power by GIFT Power Company Limited from Hybrid Renewable Energy (Solar & Wind) Developers on Long-Term / Medium-Term / Short-Term basis (As decided by RE Developers/Generators)

1. Introduction:

"Gujarat International Finance Tec-City" (GIFT) is a Project of National Importance and India's First Operational Smart City with a vision to become Global Financial & IT hub. GIFT City is being implemented at or above par with globally benchmarked financial centers and is located in proximity to Ahmedabad - Gandhinagar in the State of Gujarat.

To develop, implement, maintain and provide services in GIFT City, the Government of Gujarat has established "Gujarat International Finance Tec-City Company Limited" (GIFT CL).

GIFT CL is engaged in the business of implementing specialized infrastructure and provide services like Power, Water, District Cooling System (DCS), Automatic Waste Collection System (AWCS) and Information & Communication Technology (ICT) in GIFT City.

GIFT Power Company Limited (GIFT PCL) (hereinafter referred to as "Procurer"), is a wholly owned company of Gujarat International Finance Tec-City Company Limited (GIFT CL) incorporated under the Companies Act 1956, having its registered office at EPS Building No. 49A, Block 49, Zone 04, Gyan Marg, GIFT City, Gandhinagar, 382355, Gujarat.

GIFT PCL is a Distribution Licensee for supply of electricity in the GIFT City area which includes both Special Economic Zone (SEZ) area and Domestic Tariff Area (DTA). The Hon'ble Gujarat Electricity Regulatory Commission (GERC) has granted the license for distribution of electricity vide Order dated 6th March-2013, through Licence No. 1 of 2013 to GIFT Power Company Limited.

GIFT PCL is procuring power from Open Access as a Distribution Licensee and intends to procure Hybrid (Solar + Wind) Renewable Energy for meeting the increasing demand of licensee area and also to fulfill its Renewable Purchase Obligation (RPO).

2. Background and Objective of the EOI:

India is running one of the world's biggest renewable energy transition program, in order to fight climate change, the Government of India has also pledged to increase the country's renewable energy capacity to 500 GW by the year 2030. Accordingly, Renewable Purchase Obligations (RPO) trajectory has been given to all obligated entities up to the year 2030.

In view of the growing demand in GIFT city and fulfilment of RPO, GIFT PCL intends to procure 9 MW of Hybrid RE (Solar + Wind) for meeting the increased demand of licensee area. The procurement is aimed at enhancing energy security, ensuring a reliable supply of electricity and showing our commitment towards sustainable development.

The primary objective of this Expression of Interest (EOI) is to identify and engage the potential generators/developers who can supply 9 MW of Hybrid RE (Solar + Wind). The procurement will focus on securing a reliable, cost-effective and sustainable energy supply.

This EOI has been floated to assess the market potential and procure power from interested hybrid renewable energy suppliers. Based on the EOI response, GIFT Power Company Limited may execute a bilateral PPA with the most competitive source. The terms and conditions of the PPA except those provided in this EOI, will be similar to the PPA's executed under "MNRE Guidelines for Tariff Based Competitive Bidding Process for Procurement of Power from the Grid Connected Wind Solar Hybrid Projects". However, GIFT PCL reserves its right to approve and modify the above PPA including commercials.

Prior to the signing of PPA, technical discussions/clarifications/presentations shall be held with the Hybrid RE Generator and additional details if required will be sought at later stage.

3. Participant's Eligibility Condition:

- The Participant shall be a RE Generating Company/RE Developer/Power Trader/Consultant. The Participant may be a single Company or a group of Companies ("Consortium") coming to implement the Renewable Energy Hybrid (Solar + Wind) Project. A Company registered in India, having CIN, GSTIN, and PAN shall be eligible to participate in the EOI.
- The Participant shall have commercially operational or under implementation of Renewable Energy (Solar/Wind/Hybrid) Generating plants with a cumulative capacity of at least 50 MW within India.

4. Brief Scope of the Power Procurement:

Brief scope of Power Procurement by GIFT PCL under this EOI is mentioned below:

4	Contract Period	As decided/mentioned by the Participant
5	Delivery Point	STU Interconnection Point or CTU Interconnection Point
6	Expected CUF	50 % to 60% on Annual basis

9	Late Payment Surcharge	The marginal cost of funds based on lending rate for one year of the State Bank of India, as applicable on the 1st April of the financial year in which the period lies, plus five percent and in the absence of marginal cost of funds based lending rate, any other arrangement that substitutes it, which the Central Government may, by notification, in the Official Gazette, may specify.
10	Payment Security Mechanism	Adequate Payment Security shall be provided to the Supplier. The Payment Security shall be in the form of a Bank Guarantee or Standby Revolving Letter of Credit with a value of estimated 45 days of average billing valid for the term of the PPA.
