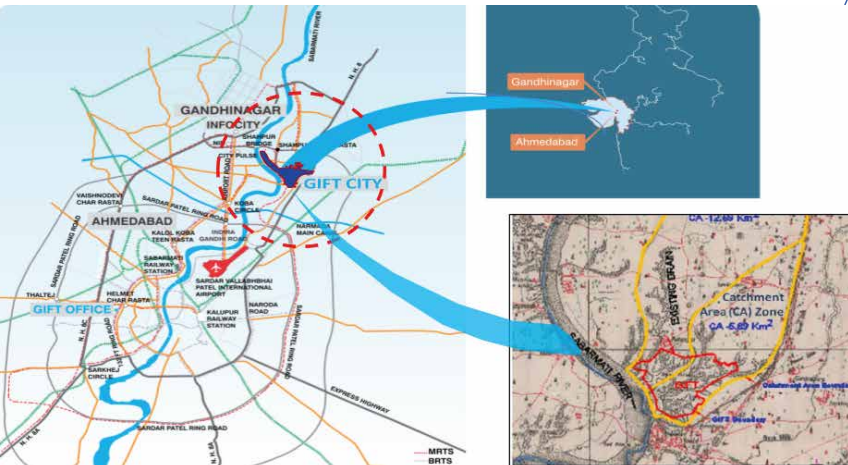

Gujarat International Finance Tec-City (GIFT City)—India's first operational smart city and International Financial Services Centre (IFSC)—is a planned business district located on the banks of the Sabarmati River between Ahmedabad and Gujarat's capital city Gandhinagar. 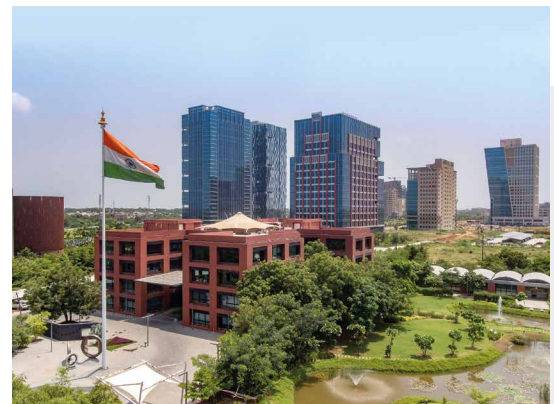

Known as India's gateway to the developed world, IFSC facilitates the movement of international financial services, acting as a jurisdiction distinct from the home country. The IFSC is designed with the aim of offering global standards of financial services to non-residents and residents, in any currency except the domestic one, while ensuring adherence to the prevailing best-in-class regulations. Such centres deal with the flow of finance, financial products, and services across borders and, in the Indian context, the IFSC is “a jurisdiction that provides financial services to non-residents and residents (institutions), in a foreign currency”.

IFSC propels India's emergence as an economic powerhouse, fostering a compelling ecosystem for financial services businesses on a global scale.



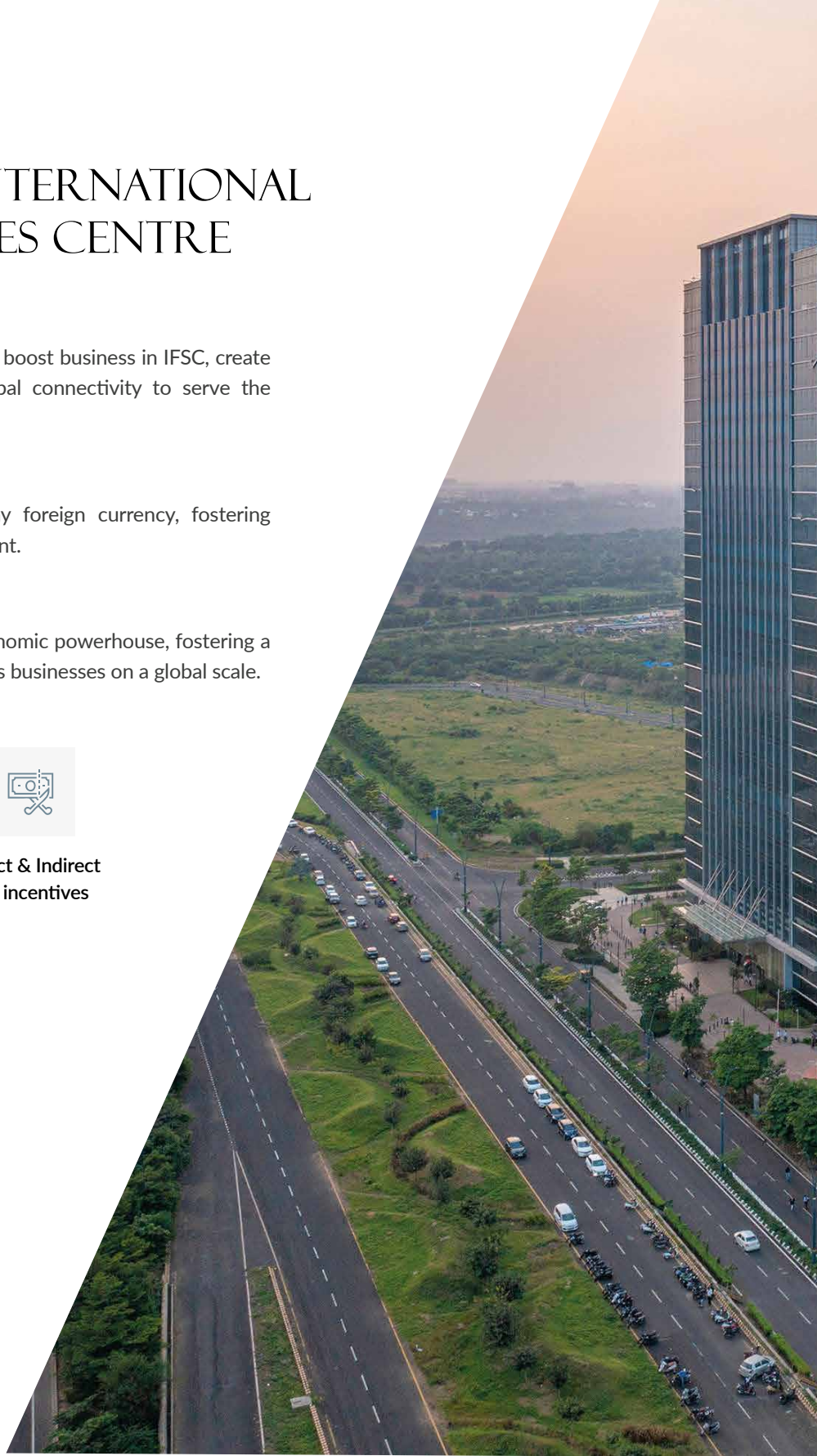
